Journal "Modern innovations, systems and technologies": rules for the design of articles

GENERAL REQUIREMENTS

The journal "Modern Innovations, Systems and Technologies" accepts articles in Russian and English. The publication is an interdisciplinary scientific and technical journal covering fundamental and applied research in various branches of technical sciences in accordance with the stated rubrication. The journal publishes articles of a problematic and scientific-practical nature, describing the results of research that are novel and of interest to a wide range of readers of the journal.

The article must correspond to the subject of the journal. The editorial board considers the materials received from the authors only if the authors fulfill the conditions of publication and the compliance of the author's originals with the requirements established by the editors.

The decision to publish the article (or reject the request) is made by the <u>editorial board</u> after its <u>review</u> and discussion.

The editorial staff of the journal adheres to the rules of <u>editorial ethics</u> in accordance with the principles and requirements of the <u>Committee on Publication Ethics (COPE)</u> and the Association of Scientific Publishers and Editors (ANRI).

When reviewing an article, the material is checked for originality. In case of detection of numerous borrowings, the editors act in accordance with the COPE rules. The recommended level of originality of the submitted material is at least 60-80%.

The editors reserve the right to make editing or stylistic changes in the text that do not affect the content of the article, without the consent of the author(s). Manuscripts submitted to the editorial office cannot be published earlier in other publications (publishing houses) or simultaneously sent for publication to other publications (publishing houses).

In one issue of the journal, the author has the right to publish once, the second time as a coauthor. The recommended number of authors of one article is no more than five.

Submission of articles for publication in the journal and their reviewing is done ONLY through a specialized website: <u>www.oajmist.com</u>. To prepare articles, you must use these recommendations and the template given below.

GENERAL REQUIREMENTS FOR THE STRUCTURE AND CONTENT OF ARTICLES

Title. Contains basic keywords, abbreviations and formulas cannot be used. The title usually consists of no more than 12 words.

Abstract. The abstract must fully correspond to the content of the work. Articles without abstracts are not considered. The abstract should not contain abbreviations, abbreviations and links. The volume of the abstract should be 150-250 words. The abstract is provided as a single

paragraph. An abstract is a brief description of a scientific article in terms of its purpose, content, type, forms and other features.

Keywords. Key words (phrases) should correspond to the topic of the article and reflect its subject, terminological area. Keywords are required. Terms-phrases are considered as one keyword. Do not use generalized and polysemantic words, as well as phrases containing participial phrases. As a rule, the article is given from 5 to 10 keywords (phrases).

Acknowledgements. This section is optional. The author can express his gratitude to colleagues for their help, gratitude for the financial support of the study. This section provides information on research funding under various grants.

The article must be structured. It is recommended to have sections corresponding to the most common model for the structure of scientific articles - IMRAD: Introduction, Materials and Methods, Results and Discussion, Conclusion.

Introduction. It includes the relevance of the research topic, a review of the literature on the research topic, the formulation of the research problem, the formulation of the goal and objectives of the research.

Materials and methods. This section describes in detail the methods that were used to obtain the results. Usually, the general outline of the study is given first, then they are presented in more detail so that any competent specialist can reproduce them using only the text of the article.

Results. This section presents experimental or theoretical data obtained during the study. The results are given in the processed version: in the form of tables, graphs, organizational or structural diagrams, equations, photographs, drawings. This section contains only the facts. Leave their interpretation, comparison with the data of other researchers for the Discussion section.

Discussion. The Discussion section contains an interpretation of the results of the study, assumptions about the facts obtained, a comparison of our own results with the results of other authors. In the Discussion, one moves from the specific information in the Methods and Results sections to a more general interpretation of the results.

Conclusion. The conclusion contains the main ideas of the main text of the article. Conclusions and recommendations are given, the main directions of further research in this area are determined.

References. This section is carried out in accordance with the requirements of the Vancouver Style, indicating the source of the DOI index at the end (if any).

PUBLICATION FORMAT

- From 6-8 pages of printed text, in doc./docx format. The volume of the manuscript should not exceed 30 pages for review theoretical and discussion articles and 15 pages for other materials (including tables, illustrations, list of references).

- Paper size A4 (210 x 297 mm).
- Sheet margins: right 25 mm, left 25 mm, top 25 mm, bottom 25 mm.
- Title, abstract, keywords single spacing, text of the article and literature one and a half

spacing.

- The main text is typed in Times New Roman, size 12, one and a half spacing.

- The height of letters, numbers and other characters in tables and figures is recommended to be 12 point size (not less than 10).

- Paragraph indentation of the main text 1.25 mm.

- Figures are included in the text of the article, they must be of good quality.

STRUCTURAL ELEMENTS OF MANUSCRIPT AND REQUIREMENTS FOR THEIR FORMATTING

- Title of the article (lower case, the first word starts with a capital letter; bold type, size 17, centered).

- Initials and surnames of the authors (initials before the surname, in the center, lower case, first letters are capital, with spaces between the initials, superscripts if necessary to clarify the affiliation with the organization, size 12, regular font). It is recommended to indicate no more than 5 authors.

- Full name of organizations affiliated with the authors, city, country (point size 12, italics, centered).

Annotation in Russian (150-250 words, normal, size 11, title Annotation: at the beginning of the line without indentation, size 11, italics, bold, additional spacing 6 pt before the paragraph)
Key words (from 5 to 10 words or phrases, size 11, normal, title Key words: at the beginning of the line without indent, before the paragraph, additional spacing 6 pt).

- Acknowledgments is an optional section, at the discretion of the authors.

Main body of the article:

- should be structured, it is recommended to use the following structural elements:

introduction, materials and methods, results, discussion, conclusion;

- all formulas must be in editable form, typed in the MathType formula editor.

- headings of all subsections without numbering, centered, without paragraph indentation, above and below the heading indent 12 pt. Headings of the first level in capital letters, bold; second-level headings - capitalize only the first word in bold, third-level headings capitalize the first word, italic.

- do not leave half a page blank, but move the text before or after the picture

- a list of sources used is required (at least 10 sources).

- references should be indicated in the text of the article in ascending order, using Arabic numerals in square brackets, all references in the text to the authors should correspond to specific sources in the list.

- journal articles are recommended, mainly included in citation and analytical databases and / or publications included in the List of peer-reviewed scientific publications, the Russian Science Citation Index (RSCI), the Core of the RSCI. Self-citation of authors - no more than 30% of the number of sources.

- format the list of sources using the Microsoft Word tool as a numbered list in square brackets, the title is REFERENCES (uppercase, bold).

At the end of the article, information about all the authors of the article should be indicated in the format, in the form of a table with invisible borders (Times New Roman font, size 12), title - (Times New Roman font, size 12, bold).
